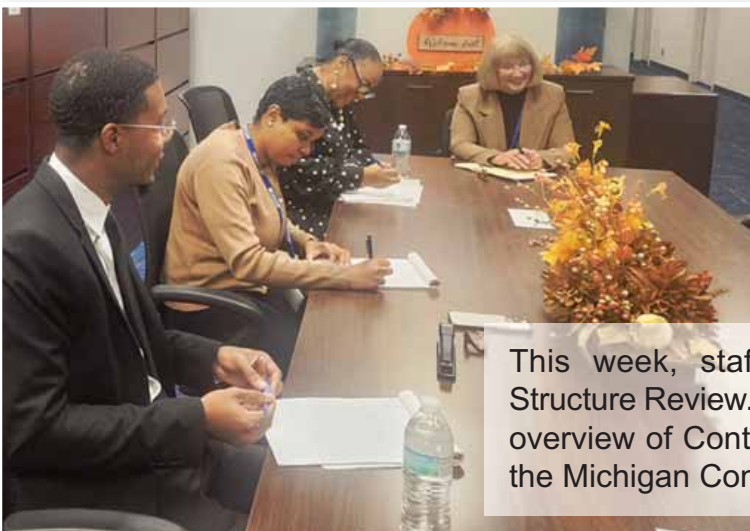

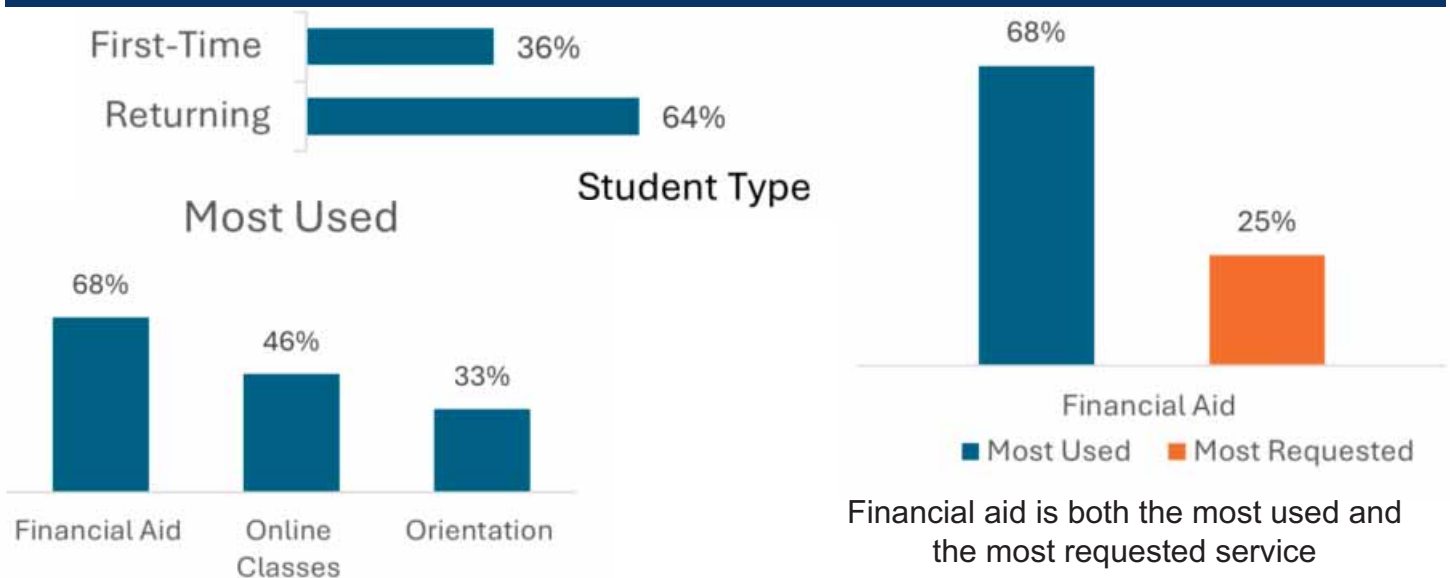
Staff continue to receive training to provide the best customer service District-wide.

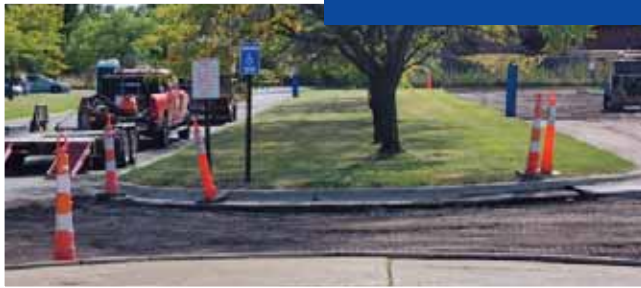

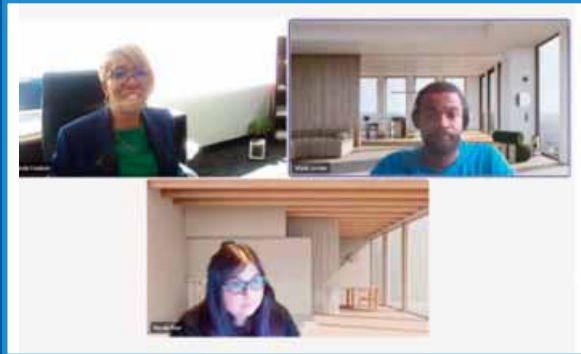
City of Detroit's Director of Entrepreneurship and Economic Opportunity

In the Legislative News...



CAPITOL UPDATE

Friday, September 5, 2025

Session Activity

House Bill 4746, sponsored by Rep. Jason Woolford (R-Howell), would replace the magnetic strips on state-issued Bridge cards with chip-enabled technology to help prevent fraud. The House approved the bill in a 77-28 vote.

House Republicans approved House Bill 4024, sponsored by Rep. Joe Fox (R-Fremont), to require transgender students to use restrooms and locker rooms based on their sex at birth, rather than their gender identity. The measure passed along party lines and is not expected to move in the Senate.

Committee Activity

The House Insurance Committee unanimously passed a comprehensive legislative package addressing Insurance Fraud, House Bills 4713-4719, which is being led by the Department of Insurance and Financial Services (DIFS).

The House Rules Committee heard testimony on House Bill 4039, which would require a state department or agency to repeal two existing administrative rules each time it proposes a new one. Proponents of the bill argue this will lift the burdens of overregulation in the state.

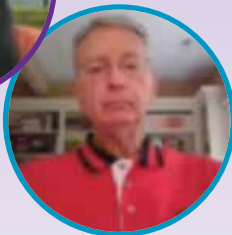
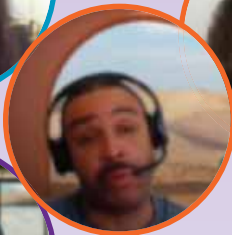
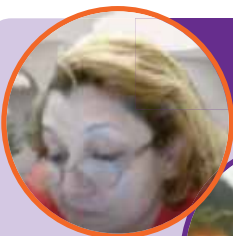
The Senate Energy and Environment Committee advanced SB 394, SB 395, and SB 396, bills designed to speed up approval of carbon capture and storage (CCS) projects that store industrial CO₂ emissions underground. These bills also passed the full Senate this week with SB's 394 and 396 passing 29-7 and SB 395 passing 31-6.

In Other News

- Thousands of road workers and unions from across the state rallied at the Capitol Wednesday, urging lawmakers to pass a long-term road and bridge funding plan. Workers warned of job losses, worsening infrastructure, and the need for real investment, not short-term fixes.
- Budget talks between House Speaker Matt Hall (R-Richland Twp.) and Senate Majority Leader Winnie Brinks (D-Grand Rapids) broke down again this week. Hall faulted Senate Democrats for lacking a roads plan, while Brinks accused Republicans of pushing harmful cuts to schools, health care, and public safety.
- At a press conference this week, Speaker Matt Hall (R-Richland Twp.) called on the board of directors for the Michigan Health and Hospital Association (MHA) to fire their CEO Brian Peters after MHA warned the House Republican budget, House Bill 4706, could cut \$2.5B in hospital funding, risking 20,000 job losses and a \$4.9B economic hit. Speaker Matt Hall has dismissed the concerns as partisan position.
- The CEO of the Michigan Economic Development Corp. (MEDC) has been identified as a "potential target" in the Attorney General's criminal investigation surrounding a \$20 million grant managed by the agency, according to a court filing submitted Tuesday.
- Governor Whitmer has called the special primary election in the open 35th Senate district for February 3rd and the special general election for May 5th. The seat has been vacant since former Senator Kristen McDonald Rivet won her Congressional race last election cycle. The 35th Senate District is made up of portions of Bay, Saginaw, and Midland Counties.
- Michigan is projected to be the second-highest state for 2026 election spending, with \$936 million in campaign advertising due to its open governor and U.S. Senate races. California leads with \$1.1 billion, while other top states include Georgia \$757M, North Carolina \$669M, Texas \$556M, New York \$494M, and Florida \$490M, according to AdImpact.

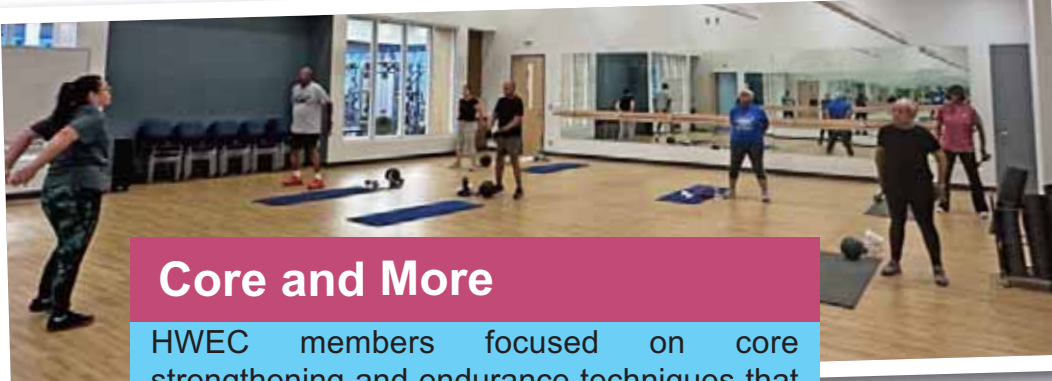
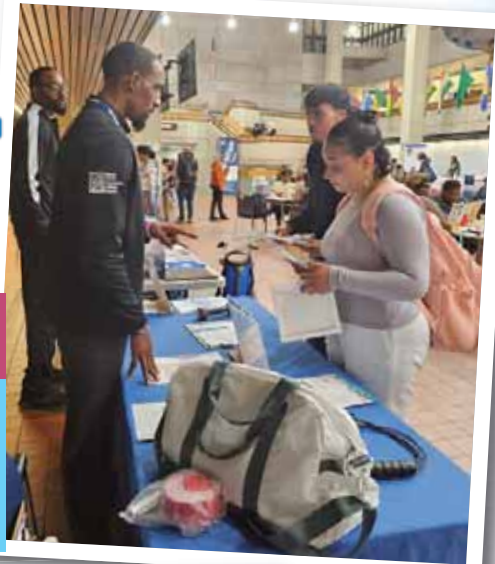

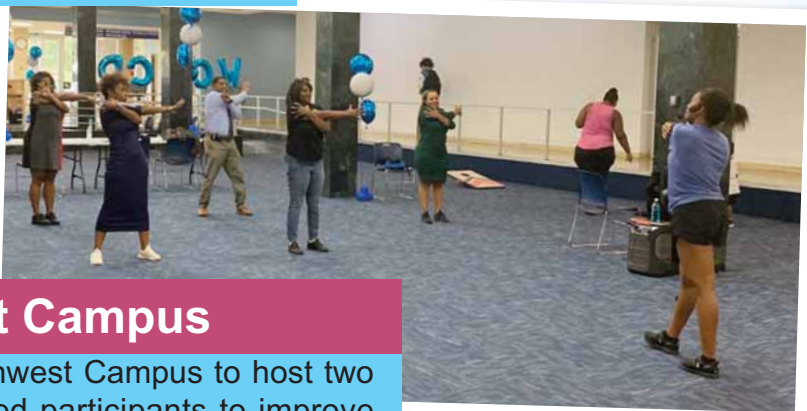
Welcome Week
