CAPITOL UPDATE

Friday, August 29, 2025

Session Activity

The Senate passed [Senate Bill 246](#) and [Senate Bill 247](#) to raise hazardous waste tipping fees and ban disposal of high-level technologically enhanced naturally occurring radioactive material (TENORM), with supporters citing protections for Southeast Michigan residents.

Nearly two months past the July 1 deadline, the House approved a \$54B omnibus budget, bringing total FY spending to \$78.5B, which is \$3B less than the current year, \$5B below the Governor's plan, and \$6B under the Senate's. The bill passed 59–46 with only one Democrat, Rep. Karen Whitsett (D-Detroit), in support. Key highlights:

- Transportation: \$10.2B MDOT budget - a record and \$3.3B higher than Senate's.
- Earmarks: \$100M for 62 earmarks, down sharply from prior years.
- Cuts/Eliminations: 4,300 unfilled FTEs, SOAR funding, and Michigan State Police cuts.
- New Provisions: Auditor General audit of SOS voter roll process; state workers back in-office; bans on taxes for tips/overtime; restrictions on AG lawsuits; E-Verify mandates for contractors; ban on state funds for DEI.
- Corrections: Ends funding for 695 FTEs and bars state dollars for prisoner gender reassignment surgery.
- Health: Substantial cuts including a \$26.4M cut to Medicaid tied to federal eligibility changes.

Speaker Matt Hall (R-Richland Twp) reinforced his position that the Senate Democrats need to release a road funding plan of their own before serious budget negotiations can move forward. Both Governor Whitmer and Speaker Hall continue to publicly push for a road funding plan in conjunction with the FY 26 budget.

Committee Activity

The House Oversight Committee authorized Chair Jay DeBoyer (R-Clay) to subpoena AG Dana Nessel for a September 16th hearing on her decision not to pursue two cases where she may have had personal or political ties.

- One involves Fair and Equal Michigan, a ballot committee once led by Nessel's wife, Alanna Maguire, and funded through the 501(c)4 Bipartisan Solutions, which failed to disclose donors.
- The other concerns attorney Traci Kornak, then-Michigan Democratic Party treasurer, accused of using a client's account for insurance fraud.

In Other News

- The Department of Transportation reports that about 100 Michigan bridges could close by 2035 without new funding, affecting 1.8 million daily drivers. Without a comprehensive funding plan, MDOT also projects the capital highways program will support 2,800 fewer jobs in 2026.
- Governor Whitmer announced Michigan surpassed its goal of 75,000 new or rehabbed housing units over a year early. Originally set for 2026, the target has now been raised to 115,000 units by the same deadline, a 53% increase.
- The Board of Education voted to appoint Dearborn Superintendent Glenn Maleyko as the next State Superintendent, with final contract approval set for September 9th. Maleyko will replace Michael Rice and is expected to assume the role by the October 14th board meeting. The vote followed final interviews with Maleyko, Harrison Community Schools Superintendent Judy Walton and former Virginia State Superintendent Lisa Coons.

Fall 2025 Faculty Organization Day

We were pleased to host the Fall 2025 Faculty Organization Day in the Heinz C. Prechter Educational and Performing Arts Center at the Downriver Campus. The event, centered on the theme “Bridging Access, Innovation, and Opportunity in an AI-Driven Future,” featured keynote speaker Dr. Denise Taliaferro Baszile, Dean of the College of Education at Wayne State University. Faculty engaged in dynamic workshops that fostered collaboration and innovation for a successful start to the new semester.

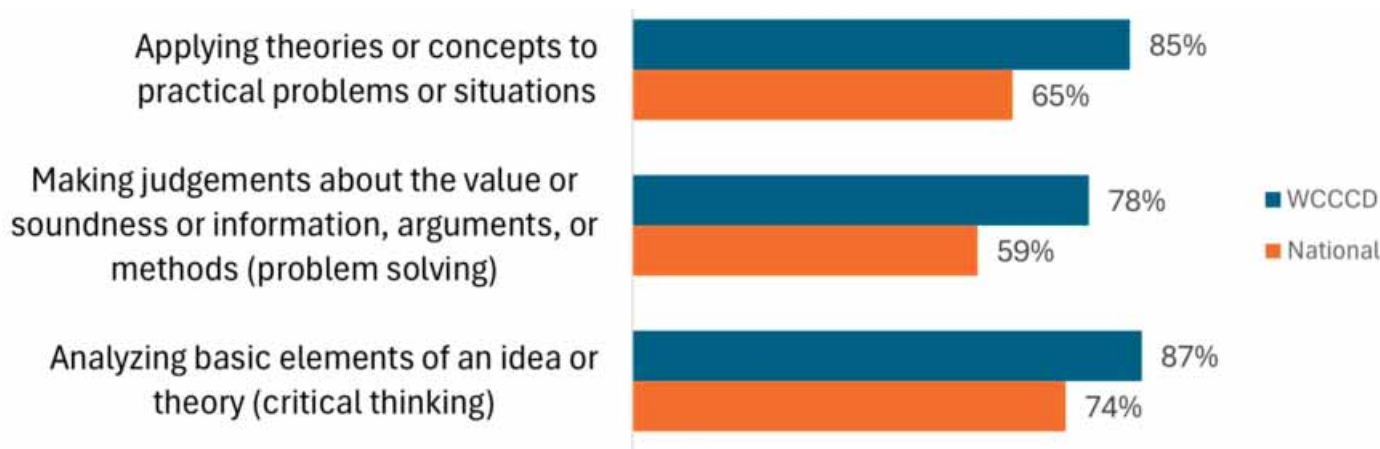

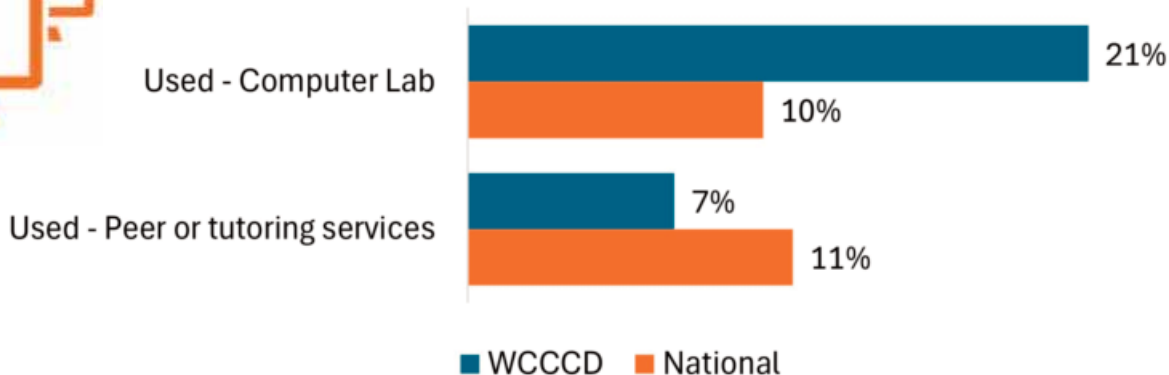

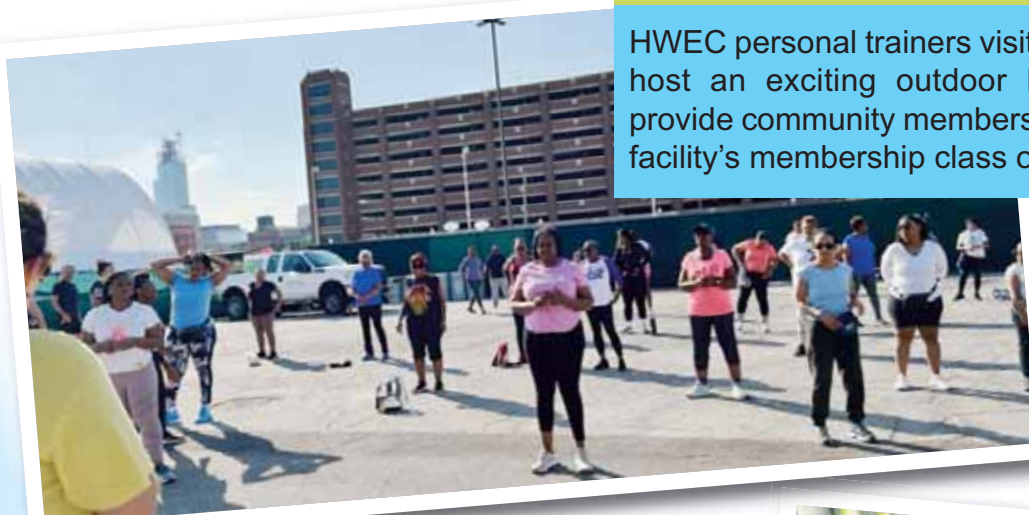
CPR Class
